The undersigned hereby release, waive, discharge and covenant not to sue KBB, Berkeley County or other agencies, partners, cooperating landowners, event volunteers and coordinators, sponsors, and any of the offices, servants, agents and employees of the above-mentioned entities (hereinafter referred to as "RELEASEES") for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including but not limited to drowning or other event-related death, that occurs as a result of participation in the cleanup.

The undersigned agrees to hold harmless the RELEASEES whether injury is caused by the undersigned's negligence, the negligence of the RELEASEES or the negligence of any third party. The undersigned further agrees that this Release and Waiver of Liability shall bind members of family and spouse and any heirs, assigns and personal representatives, and in case of death, shall be deeded as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the abovenamed RELEASEES.

By signing this form both parties agree that Berkeley County is not affiliated with this agreement and is in no way subject to any liability, responsibility, or obligation that may arise from any incident associated with volunteer activities.
